UTILITY AND PUBLIC SERVICES FEE SCHEDULE

WHEREAS, The Graceville Board of City Commissioners enacted Section 9, entitled General Powers, of the City Charter, and

WHEREAS, it is necessary for the City to provide utilities and public services to its citizens, and

WHEREAS, Section 9 provides that the City Commission may establish and collected necessary fees for utilities and public services provided, and

WHEREAS, the City Commission, by Resolution no. 06-0215, established certain fees for utilities and public services, and

WHEREAS, the City Commission has determined that the fees for Garbage service should be changed.

NOW, THEREFORE, BE IT RESOLVED by the Board of City Commissioners of Graceville, Florida as follows. The following fees are hereby established:
